All types of tickets are non-transferable and will be withdrawn if misused without a receipt from RTC Ski Lift, Kranjska Gora, d.o.o. staff.

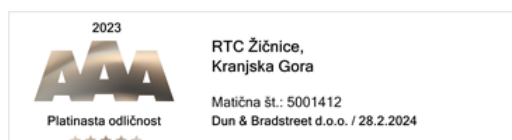
When purchasing tickets for children, youth and seniors, ID must be presented at the ticket office.
